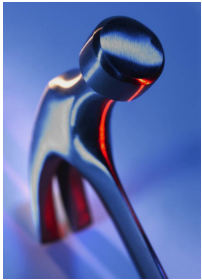

**How to Compute Your Chamber Dues:**

Employee Basis: The base rate is \$329 for up to 5 employees with an additional \$10 per employee over 5 employees. For example, a firm has 12 full time employees:

Base Rate (1-5 employees) = \$344.00  
7 (additional employees) x \$10 \$ 70.00  
*Note: 2 part-time = 1 full-time*  
One-time administration fee \$ 30.00  
Total Chamber Investment \$444.00

The Federal Government requires the Chamber inform you that:

The Chamber is a 501(c) (6) organization; 95% of membership dues is deductible as an ordinary and necessary business expense for Federal income tax purposes; that in compliance with the Omnibus Budget Reconciliation Act of 1993, 5% of your membership dues are not deductible as a business expense because it is allocable to lobbying expenditures; contributions or gifts to the Chamber are not deductible as charitable contributions, but may qualify as a business expense; further information on this law should be obtained from your tax advisor; and that the Chamber does have a 501(c) (3) tax deductible Foundation as well.

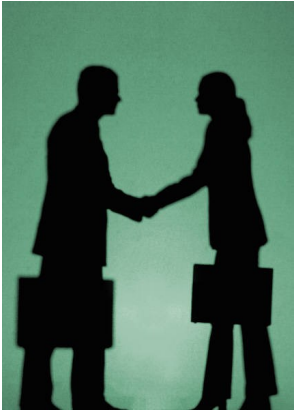
